In this role, you will review engineering designs and monitor the construction of surface and underground improvements in residential and commercial subdivisions to ensure compliance with the City of Edmonton standards and conditions of the development agreement.

The Development Planning and Engineering Section of Transportation Planning Branch, reviews and approves the transportation components of land use plans and engineering designs for new growth areas, which carries into inspection and acceptance of all the City's private roadway development. This team may also administer and apply the Arterial Roadway Assessment Bylaw.

Reporting to one of the Senior Technologists of Development Engineering, responsibilities include but are not limited to, the review of Engineering Drawings to service pending private development construction projects and ensuring that the Engineering Drawings conform to applicable Transportation design guidelines, standards, and applicable subdivision requirements or development permit conditions and performing field work that ensures developer's road construction requirements are met. Key functions are:

- Provide quality control review of engineering drawings submitted by external design consultants and City Departments
- Ensure completion of concept, preliminary and engineering drawings review in a timely manner, with high level of accuracy and within TAC, City, and other applicable standards and guidelines
- Assist in monitoring engineering design drawing submissions and track progress to ensure engineering drawings goals and objectives are met
- Design and prepare concept level roadway engineering drawings for the section by using Microstation and various other CADD design tools and design guidelines
- Complete design requirements as needed to support the Arterial Roadway Assessment process
- Conduct field reviews of various engineering design drawing submissions to ensure accuracy with field conditions
- Observe and report road construction activities
- Review and approve Utility Line Assignment (ULA's) plans
- · Contribute to the technical review and update of the City of Edmonton Design & Construction Standards
- Ensure efficiency of database system to track all working and approved drawings and documents
- Conduct field reviews of various engineering design drawing submissions to ensure accuracy with field conditions
- Interact with Administration and the General Public as required in response to inquiries, concerns, and requests for information
- Supervise, mentor, and coordinate with Engineering Technologist I to ensure proper coverage of duties in active construction sites
