The Township of Langley is currently recruiting for 2 auxiliary **Recreation Leaders – Fitness** to join our team of professionals in the Parks and Recreation Division; Recreation Programs and Services Department. We believe in building individuals and communities to be active and healthy for life.

Reporting to the Community Recreation Programmer, you will be responsible in this unionized position for assisting a supervisor in planning, developing, and scheduling specific fitness and recreation programs, services and special events; directing the implementation of program activities; providing leadership and instruction; assessing program results and recommending changes as necessary. You will also be responsible for assigning and supervising the work of auxiliary staff; providing orientation and training; and participating in the selection and evaluation of staff.

Your education will include completion of a two year program in Recreation at a recognized Community College and some related community recreation experience, or an equivalent combination of training and experience. Sound knowledge of the fitness and recreational needs and interests of the area served, and sound knowledge of the principles, practices and objectives of community recreation programs. BCAK Practicing Kinesiologist, BCRPA Personal Training Certificate, BCRPA Group Fitness Certificate (or equivalents), and experience with fitness programs or working in a community fitness centre would be an asset. Shortlisted candidates must be available to interview on November 8 and 9.

This position is defined by the Township of Langley as a position of trust (Child Safety). The successful candidate will be required to have a criminal record check as a condition of employment (Note - Not required as part of the application process, however will be required upon consideration for employment).

In order to be considered for this position, candidates must have the following valid and current certifications / licenses (must be valid at the time the posting closes) and these **must** be attached with your application. **Applications without the attached required documents below will be deemed incomplete and will not be considered.** Please title your attachments with the number of this competition and have these documents ready to upload when you apply:

The CUPE rate of pay for this position is \$25.33 - \$29.77 per hour (5 steps, 2017 rates), plus 12.4% in lieu of benefits. The hours of work are non-standard hours and/or non-standard work week.
