POSITION OVERVIEW

The Mental Health and Addictions Program Coordinator provides leadership and expertise in substance misuse prevention, addictions and mental health from a population health perspective. This position will lead Lambton Public Health's Mental Health and Addiction community engagement and planning efforts. Responsibilities will include leading systemlevel implementation and evaluation of a community mental wellness strategy including substance misuse, addictions, overdose response, harm reduction outreach and opioidrelated community issues.

DUTIES AND RESPONSIBILITIES

Policy Development:

• Work with outside agencies, community partners, schools and workplaces to develop policies to create supportive environments for positive mental health, reduce and prevent substance misuse, and improve access to harm reduction services.

• Implement local advocacy activities that support provincial legislation

Program Planning and Evaluation:

• Conduct population health assessments related to mental health and addictions, harm reduction and overdose response.

• Lead and support development and evaluation of local drug strategy including overdose response, harm reduction outreach and opioid-related community issues.

• Consult with and support program staff and management throughout the integrated planning and evaluation cycle.

• Assess and identify organizational training and development needs related to mental

health in consultation with program managers and the epidemiologist.

Research, Data Analysis, Interpretation and Communication:

• Research mental health issues in response to community concerns, as directed by senior management.

• Maintain current knowledge of effective community interventions for mental health and addictions.

• Communicate assessment, surveillance and evaluation information to program staff and management for use in setting team priorities, program planning, and resource allocation.

• Interpret current scientific information related to programming.

• Write technical reports.

Collaboration and Engagement:

• Strong knowledge of local Mental Health and Addictions services and demonstrated relationship building ability.

 Use appropriate methods to engage with internal and external stakeholders, including priority populations, in the planning and evaluation of addiction and mental health strategies and initiatives.

• Identify and leverage stakeholders and partners including Indigenous Communities to support population health assessment and local overdose response initiatives.
