PRIMARY PURPOSE

Develops and manages BCRTC asset and investment plans with the emphasis on both asset management and financial aspects in support of TransLink 10 year investment plan and the strategies and business plan of the rail company.

- Develops and manages BCRTC 10 year Annual Asset Renewal Plan according to BCRTC asset management plans and capital investment plans in liaison with multiple stakeholders across the enterprise including Operations and Maintenance Capital Working Groups, TransLink Strategic Planning & Policy department, and Financial Planning & Analysis department.
- Develops plan definitions, financial forecasts and analysis, and ongoing operating financial modelling related to the plan and asset life-cycles.
- Provides finance specific input and advice to the Director on asset planning strategies and develops BCRTC detailed capital investment plans in alignment with the 10 year investment plan.
- Develops and implements BCRTC's Investment Protocol (IP) in combination with supporting templates to ensure a systematic and sound business analysis of proposed investments including standardized asset applications and verification of investment needs, with overall alignment to TransLink's Investment Protocol.
- Provides single point contact for BCRTC on all asset and investment planning requirements related to the support of the Annual Asset Renewal Plan, including proposed service plan enhancements/scenarios, upgrades, and expansions to ensure consistent and aligned support.
- Accountable for the creation and maintenance of an Assumptions Log and tracking system for all scenario costing submissions.
- Liaises with BCRTC Asset Integration Office to ensure that the ongoing 3 year capital plan is updated and reflects all asset condition assessment, refurbishment and overhaul activities.
- Develops, recommends and circulates Department capital asset policy by instituting a life cycle focus
 for investments, and ensuring all capital activities (from acquisition through disposal) are
 accomplished in concert with the Division's strategic vision and strategic management process.

- Provides capital investment planning expertise to executives and senior leaders. Develops and presents reports and analysis related to Asset and Investment Planning.
- Supports change management related to Investment plan initiatives, identifying emerging issues and
 risks, and developing resolution for complex financial issues and escalating for adequate closure,

- Manages reporting staff, including selection, development, coaching, managing performance, and all other people management practices.
