Currently, we are looking to fill the following vacancy:

HVAC Technician

Permanent, full-time

Hourly rate: \$36.79 - \$45.98 based on a 40-hour work week.

Reporting to the Manager, Facilities, the main purpose of the HVAC Technician position is to service, maintain, repair, and replace the heating, ventilation, air conditioning equipment for all Northumberland County facilities. This position will also be responsible for contacting contractors, as well as working with the contractors to schedule, organize, provide instruction of work to be preformed.

Major Responsibilities:

- Service, maintain, repair, and replace the heating, ventilation, air conditioning equipment for all Northumberland County facilities.
- Work on facilities with BAS (Building Automation Systems).
- Organize and instruct contractors preforming work on County buildings, ensure contractors work safely and comply to Occupational Health and Saftey Standards.
- Complete paperwork, files, reports, work orders, service manuals for mechanical equipment, and daily time documentation.
- Report to the Manager of Facilities with any questions on daily work orders, progress reports on capital projects, aging equipment years in service for planning of replacement capital budgets, and any requests to purchase supplies for operating budgets (furnace parts, special tools, etc.).
- Overtime, evening, and weekend work may be required as needed.
- After hours on-call will be required for this position.
- Operates and maintains a County owned vehicle including fueling, cleaning, and scheduling regular maintenance.
- Work locations are throughout Northumberland County, and driving to different facilities is to be expected.
- Customer service approach to dealing with different departments, clients, tenants, staff in professional manner while ensuring client confidentiality.

Education and Qualifications:

- High school diploma or equivalent.
- Completion of an apprenticeship program in HVAC and/or Refrigeration from a provincially regulated and accredited college would be considered an asset.
- Licensing as Refrigeration air conditioning systems mechanic would be considered an asset.
- Natural Gas Fitter 2 and Propane Gas Fitter 2 certifications required; Gas Fitter 1 would be an asset.
- Five (5) years' relevant experience.
- Knowledge of the Ontario Building Code Natural Gas Code, Propane Code, and Electrical Code.
- In depth knowledge of the theory of refrigeration, air conditioning and ventilation, advanced electrical controls switches loads, and wiring diagrams.

- Advance skill level in electrical, mechanical, and schematic print reading as well as blue print reading and ability to read and understand service maintenance manuals.
- Ability to work well independently and as part of a team.
- Demonstrated organizational skills with strong oral and written communication abilities.
- Ontario Class "G" driver's licence. An acceptable driver's abstract must be submitted with your application. Applications submitted without an acceptable driver's abstract will not be reviewed.
