Reporting to the Manager, Utilities this position performs water related utility services and meter inspections and installations in accordance with standardized procedures within the City of Vernon and any contractual obligations or arrangements.

Duties Include:

- Installs, inspects, reads, tests and programs residential and commercial water meters and bypass piping which includes the placement of the official 'tamper proof seal'. This involves all aspects of remote reader installations, access to private residential property and to commercial buildings and properties. May include utilizing 'radio read' functionality.
- Performs major and minor skilled maintenance meter repairs as directed and in accordance with established procedures which meet current Canadian Plumbing Code standards.
- · Investigates and resolves public complaints.
- Locates water services (singular or blocks) by utilizing electronic and manual tracing devices, researching service cards, maps, blueprints, legal plans, as-builts and other City records. Updates with accurate information and submits record updates to the appropriate City personnel.
- Flow tests residential and commercial water meters for accuracy using flow test equipment, and recommends if replacement is required.
- Operates valves to determine accessibility and ease of function and notifies affected customers of the service change or interruption. Reports major deficiencies or replacements required related to service valve leaks.
- Operates fleet vehicles and equipment in compliance with provincial regulations and municipal bylaws. This involves vehicle and equipment checks documented and forwarded to Fleet Operations for malfunctions or required repairs.



- Call-out and shift work may be required. Responds to after hour calls and takes corrective action as required.
- · Performs other related duties assigned.
- All persons employed by the City of Vernon will be required to assist the City in providing emergency services. Duties assigned during an emergency may differ from regular duties.
